---

  - Develop a web site
  - Communicate with local media

### **CAG Technical Assistance**

---

- CAG has received the technical assistance contract from Dow
- Technical assistance funds are limited and need to be carefully planned to enhance CAG and community understanding of key issues
- Up to \$5000 can be used to assist in formational tasks such as incorporation and web site
- \$50,000 is available for technical assistance, and the contract may be renewed in the future
- January meeting topic to include about how to identify and get tech folks on board, options for how to use them and keep costs down such as webinar technology, and options for multiple points of view
- Segment 1 response proposal will be finalized in 2011 and will likely be the first item for outside technical assistance
