

Saginaw-Tittabawassee Rivers Contamination Community Advisory Group Application for Membership

Since January 2010, the U.S. Environmental Protection Agency (EPA) has supported the operation of a Superfund community advisory group or CAG. The CAG allows people in the community to provide coordinated, local input to the decision-making process at the -Tittabawassee River, Saginaw River and Bay Superfund site. It is a forum for members to present and discuss community needs and concerns and explore areas of common ground in the community. The CAG assists EPA in making better decisions by providing the Agency a unique opportunity to hear and seriously consider community preferences for site cleanups. The CAG does not replace other forms of community involvement and the CAG works closely with the broader community throughout its process.

Membership in the CAG consists of approximately 20 local residents representing a wide range of interests and viewpoints. When members leave the CAG throughout the year, re-placements are sought to represent similar interests and demographics annually in July.

Expectations of CAG Members

Membership on the CAG requires commitment to the work of the CAG. Members are expected to attend all bimonthly meetings (currently on the 3rd Monday of odd-numbered months), participate in subcommittees, read materials and background information between meetings, and help to communicate with neighbors and others in the community. In addition, the CAG seeks to find common ground where possible, requiring all members to approach each other with respect and all issues with an open mind. CAG members serve 3-year renewable terms. Total time commitment is approximately 4 hours per month.
